As provided in Rule 131 of the General Regulations, I accept Article 24 and 25 and recognize the competence of the Court of Arbitration for Sport, (CAS), and Lausanne, Switzerland as the final deciding arbitration tribunal, excluding all recourse to ordinary courts, and also all FSAT rules.*
- II) *Agree to be filmed, televised, photographed, identified, interviewed and otherwise recorded during THA National Championships, ISU Events under conditions and for the purposes now or hereafter authorized by the ISU in relation to the promotion of the Figure and Speed Skating Sports.*
- III) *Herewith confirm that I am eligible to compete/officiate according to FSAT & ISU Regulations, Rule 102. (In the case of ineligible skaters entered in Open International Competitions to be crossed out and initialled by the ineligible skater).*
