Figure and Speed Skating Association of Thailand has the honor and pleasure to invite you to a competition in the:

**2016 Thailand National Short Track Speed Skating Championships** which will be held at the Imperial World Ice Skating Samrong (IWIS) Thailand, on 22<sup>nd</sup> May, 2016.

## General Rules and Regulations

“**2016 Thailand National Short Track Speed Skating Championships**” will apply in conjunction with the 2014 Regulations of the International Skating Union competition rules where applicable and appropriate.

## Technical Data

All events as well as official practices will take place at the “Imperial World Ice Skating Samrong” (IWIS) (30mx60m) 999/1 Sukhumvit Rd, SamrongNua, Muang, Samutprakarn 10270 Thailand.

The compass of the track is 111.12 m, according to ISU Rules with curves of 8m, Pads shall be placed and be attached to the rink boards.

Skaters will be required to use all safety equipments. Knee and shin pads, neck guards, body suits, safety helmet and gloves are compulsory equipments for all competitors and must be worn appropriately. There are no exceptions, else the skaters will not be allowed on the ice to race.

Blades used in the Short Track events must be short track blades conforming to ISU regulations with tubes closed, and compulsory rounding of the corners of the blades with the blade ends rounded off with a minimum radius of 10mm.

Skaters/Teams who received a penalty, yellow card, red card, did not start or failed to finish the race cannot participate in the next round of the all final system.

## Eligibility and Requirements

Only registered competitors are allowed to participate.

The competition is open to all current members of the Figure and Speed Skating Association of Thailand (FSAT). Skaters who are not Thai citizens or Thai Permanent Residents may compete as guest skaters.

## Events and Distances

- **Short Track Speed Skate Event:** Individual Ladies and Men

SENIOR DIVISION	(Men/Ladies)	500m, 1000m, 1500m
JUNIOR A DIVISION	(Men/Ladies)	500m, 1000m, 1500m
JUNIOR B DIVISION	(Men/Ladies)	500m, 1000m, 1500m
JUNIOR C DIVISION	(Men/Ladies)	500m, 777m, 1000m
JUNIOR D DIVISION	(Men/Ladies)	500m, 777m, 1000m
NOVICE DIVISION	(Boys/Girls)	222m, 333m, 500m

Individual events will be run for both Ladies and Men in the different divisions. The combining of divisions, in the event if insufficient entries are received, is at the discretion of the competition organizers and officials. The competition organizing committee will advise participants of any of the above alterations are required. Detailed event schedule will be announced at a later date.

All final system will be used, to ensure that skaters will have a chance to race twice in each distance.

- **King of Speed Event** :222m

The race is reserved for Thai nationals only, no age or gender limit. Skaters are required to wear safety equipments and any kind of skate boots are allowed. The race will be 2 laps around the track (222m). It will be time base, the skater with the fastest time will be “King of Speed”.

## Divisions

### **SENIOR MEN AND LADIES**

**AGE LIMIT:** In accordance with the ISU Rule 108, paragraph 2 a), the participants must have reached at least the age of (15) before July 1 preceding the competition (born before July 1, 2001).  
**INDIVIDUAL DISTANCE:** 500, 1000 and 1500 meters

### **JUNIOR A MEN AND LADIES**

**AGE LIMIT:** In accordance with the ISU Rule 108, paragraph 2 b) and c), the participants must have reached at least the age of seventeen (17) and have not reached the age of nineteen (19) before July 1 preceding the competition (July 1, 1997 to June 30, 1999).  
**INDIVIDUAL DISTANCE:** 500, 1000 and 1500 meters

### **JUNIOR B MEN AND LADIES**

**AGE LIMIT:** In accordance with the ISU Rule 108, paragraph 2 b) and c), the participants must have reached at least the age of fifteen (15) and have not reached the age of seventeen (17) before July 1 preceding the competition (July 1, 1999 to June 30, 2001).  
**INDIVIDUAL DISTANCE:** 500, 1000 and 1500 meters

### **JUNIOR C MEN AND LADIES**

**AGE LIMIT:** In accordance with the ISU Rule 108, paragraph 2 b) and c), the participants must have reached at least the age of thirteen (13) and have not reached the age of fifteen (15) before July 1 preceding the competition (July 1, 2001 to June 30, 2003)

**INDIVIDUAL RACE:** 500, 777 and 1000 meters

### **JUNIOR D MEN AND LADIES**

**AGE LIMIT:** In accordance with the ISU Rule 108, paragraph 2 b) and c), the participants must have not reached the age of thirteen (13) before July 1 preceding the competition (born after July 1, 2003).

**INDIVIDUAL DISTANCE:** 500, 777 and 1000 meters

### **NOVICE BOYS AND GIRLS**

**AGE LIMIT:** The participants must have the age of ten (10) and younger before July 1 preceding the competition (born after July 1, 2006).

**INDIVIDUAL DISTANCE:** 222, 333 and 500 meters

## Seeding Procedure and Competition Format

A draw shall take place to establish the starting order of each race. Progression to subsequent rounds shall be based on time and ranking.

The individual competition is an All Round competition. All Final System is used as the qualification procedure. Final points (34,21,13,8,5,3,2,1) will be awarded in the Final-A.

## Awards

Medals will be awarded to the top three places.

## Entry Fees

Competition entry fee is 500 Baht per skater.

For FSAT non-members, have to pay the membership fee (1,500 Baht) in addition to the entry fees.

## Closing date for entries Wednesday 18<sup>th</sup> May, 2016

The Final Entry Forms including the copy of birth certificate or passport and Waiver and release form must be sent to the Competition Office not later than **18<sup>th</sup> May, 2016**. Skaters must also submit the following supplementary documents together with their entry form:

- Copy of the skater's passport or copy of the birth certificate.
- Waiver and release form

Incomplete or incorrect entry forms will not be accepted.

Late entries will not be accepted.

There will be no refund of entry fee for any skater who withdraws after the closing date for entries.

## Transportation
