**2022 Thailand National Short Track Speed Skating Championships** which will be held at the IWIS International Training Center, Thailand, on 23<sup>th</sup> March, 2022.

#### **General Rules and Regulations**

**"2022 Thailand National Short Track Speed Skating Championships"** will apply in conjunction with the ISU CONSTITUTION and GENERAL REGULATIONS 2021 and SPECIAL REGULATIONS & TECHNICAL RULES, SHORT TRACK SPEED SKATING 2021 where applicable and appropriate.

### **Technical Data**

All events as well as official practices will take place at the "IWIS International Training Center" (IWIS) (30mx60m) 999/1 Sukhumvit Rd, SamrongNua, Muang, Samutprakarn 10270 Thailand.

The compass of the track is 111.12 m, according to ISU Rules with curves of 8 m., Pads shall be placed and be attached to the rink boards.

Skaters will be required to use all safety equipment. Knee and shin pads, neck guards, body suits, safety helmet and gloves are compulsory equipment for all competitors and must be worn appropriately. There are no exceptions, else the skaters will not be allowed on the ice to race.

Blades used in the Short track events must be short track blades conforming to ISU regulations with tubes closed, and compulsory rounding of the corners of the blades with the blade ends rounded off with a minimum radius of 10mm.

Skaters/Teams who received a penalty, yellow card, red card, did not start of failed to finish the race cannot participate in the next round of the all final system.

### **Eligibility and Requirements**

Only registered competitors are allowed to participate.

The competition is open to all current members of the Figure and Speed Skating Association of Thailand (FSAT). Skaters who are not Thai citizens or Thai Permanent Residents can compete as guest skater.

#### **Events and Distances**

• Short Track Speed Skate Event: Individual Women and Men

SENIOR DIVISION	(Men/Women)	500m, 1000m, 1500m
JUNIOR DIVISION	(Men/Women)	500m, 1000m, 1500m
NOVICE DIVISION	(Boys/Girls)	500m

Individual events will be run for both Women and Men in the different divisions. The combining of divisions, in the event if insufficient entries are received, is at the discretion of the competition organizers and officials. The competition organizing committee will advise participants of any of the above alterations are required. Detailed event schedule will be announced at a later date.

#### Divisions

#### SENIOR MEN AND WOMEN

**AGE LIMIT:** In accordance with the ISU Rule 108, paragraph 2 a), the participants must have reached at least the age of fifteen (15) before July 1 preceding the competition (born before July 1, 2007).

INDIVIDUAL DISTANCE: 500, 1000 and 1500 meters

#### JUNIOR MEN AND WOMEN

**AGE LIMIT:** Skaters must have the age of eleven (11) and have not reached the age of fifteen (15) before July 1 preceding the competition (born between July 1, 2007 and June 30, 2011).

INDIVIDUAL DISTANCE: 500, 1000 and 1500 meters

#### **NOVICE DIVISION: BOYS AND GIRLS**

**AGE LIMIT:** The participants must have the age of ten (10) and younger before July 1 preceding the competition (born after July 1, 2011).

**INDIVIDUAL DISTANCE:** 500 meters

### **Seeding Procedure and Competition Format**

A draw shall take place to establish the starting order of each race. Progression to subsequent rounds shall be based on time and ranking.

The individual competition is an All Round competition. All Final System is used as the qualification procedure. Final points (34, 21, 13, 8, 5, 3, 2, 1) will be awarded in the Final-A.

#### Awards

Medals will be awarded to the top three places.

#### **Entry Fees**

Competition entry fee is 500 baht per skater. It is also required to pay the membership fee (1,500 Baht) in addition to the entry fees.

### Closing date for entries Sunday 13th March, 2022

The Final Entry Form including the <u>copy of birth certificate or passport</u> and <u>Waiver and</u> <u>Release Form</u> must be sent to the Competition Office not later than **13<sup>th</sup> March**, **2022**.
