## General

### General Regulations

The Asian Open Short Track Speed Skating Trophy will be organised in accordance with the 2018 Regulations of the International Skating Union (ISU) and relevant ISU Communications, and the conditions included in this announcement. This international competition is sanctioned by the International Skating Union (ISU).

### Participation

The Asian Open Short Track Speed Skating Trophy is open to all ISU members. Entries are to be made via the online registration at [www.fisid.org](http://www.fisid.org)

### Competition Format

All Final defined as:

Competition will use the knock out system (elimination system) as the qualification procedure. The make-up of the races will be made in accordance with Rule 296-3c), 4, 5 and 6. The lane positions of qualifying rounds will follow Rule 296-8.

Final points (34, 21, 13, 8, 5, 3, 2, 1) will be awarded in the respective Final A and Final B considering Racing Rule 297 5 a) i).

The Rink @ OCA is an artificially refrigerated indoor ice surface of 30 x 60 metres. Protective padding covers the boards in accordance with Rule 280, paragraph 5 and the respective ISU Communications. The tracks are in accordance with Rule 280-5a).

Medals will be awarded to the top three competitors in the individual events and to each member of the winning relay teams. Trophies will be awarded to the Champion of each individual division, and medals to second and third placed competitors according to overall individual classification.

All expenses incurred by competitors of each participating ISU Member will be the responsibility of the individual.

## **Citizenship / Residency Requirement and Clearance Procedure**

In accordance with Rule 109 of the ISU Regulations and the current ISU Communication, all skaters who do not have the nationality of the Member by which they have been entered, or who, although having such nationality, have in the past represented another Member, must produce an ISU Clearance Certificate.

## **Liability and Medical Insurance**

In accordance with Rule 119 of the ISU General Regulations, the ISU, the Federasi Ice Skating Indonesia and the Organising Committee assume no responsibility for or liability with respect to bodily or personal injury or property damage incurred in connection with the competition.
